### 1. WHAT INFORMATION DO WE COLLECT?

### Personal information you disclose to us

We collect personal information that you voluntarily provide to us when you register on the Website, express an interest in obtaining information about us or apply for membership, when you participate in activities on the Website (such as by posting messages in our online forums or entering competitions, contests or giveaways) or otherwise when you contact us.

The personal information that we collect depends on the context of your interactions with us and the Website, the choices you make and the services and features you use. The personal information we collect may include the following:

### **Personal Information Provided by You**

We collect and maintain a list of our members' information including (when given): names, addresses, email addresses, phone numbers, membership numbers, and, if applicable, allotment numbers. For those who pay their subscriptions by standing order, direct debit or bank transfer, we may also include bank account details.

All personal information that you provide to us must be true, complete and accurate, and you must notify us of any changes to such personal information.

### 2. HOW DO WE USE YOUR INFORMATION?

We use personal information collected via our Website for a variety of purposes described below. We process your personal information for these purposes in reliance on our legitimate interests with your consent, and/or for compliance with our legal obligations. We indicate the specific processing grounds we rely on next to each purpose listed below.

We use the information we collect or receive:

- To send administrative information to you. We may use your personal information to send you information about our Annual General Meeting (AGM) and changes to our terms, conditions, and policies.
- To send member information to you and reminders to renew your annual membership.
- To send you our newsletter, information about our parties, shows, talks and events.
- To request volunteers, to share information about work rotas in the Trading Centre and Greenhouse or to plan and arrange catering and events.
- Request feedback. We may use your information to request feedback and to contact you about your use of our Website and Services.

- Administer prize draws and competitions. We may use your information to administer prize draws and competitions when you elect to participate in our competitions.
- To deliver and facilitate delivery of services to the user. We may use your information to provide you with the requested service.
- To respond to user inquiries/offer support to users. We may use your information to respond to your inquiries, suggestions and requests, and solve any potential issues you might have with the use of our Services.

#### 3. WILL YOUR INFORMATION BE SHARED WITH ANYONE?

We do not share or sell your information to anyone outside of the Society.

## 4. DO WE USE COOKIES AND OTHER TRACKING TECHNOLOGIES?

We may use cookies and similar tracking technologies (like web beacons and pixels) to access or store information. Specific information about how we use such technologies and how you can refuse certain cookies is set out in our Cookie Notice: http://www.growchiswick.org/cookies.

### 5. HOW LONG DO WE KEEP YOUR INFORMATION?

We will only keep your personal information for as long as it is necessary for the purposes set out in this privacy notice, unless a longer retention period is required or permitted by law (such as tax, accounting or other legal requirements). No purpose in this notice will require us keeping your personal information for longer than twelve (12) months past the termination of the user's membership.

When we have no ongoing legitimate need to process your personal information, we will either delete or anonymize such information.

### 6. HOW DO WE KEEP YOUR INFORMATION SAFE?

We have implemented appropriate technical and organizational security measures designed to protect the security of any personal information we process. However, despite our safeguards and efforts to secure your information, no electronic transmission over the Internet or information storage technology can be guaranteed to be 100% secure, so we cannot promise or guarantee that hackers, cybercriminals, or other unauthorized third parties will not be able to defeat our security, and improperly collect, access, steal, or modify your information. Although we will do our best to protect your personal information, transmission of personal information to and from our Website is at your own risk. You should only access the Website within a secure environment.

### 7. WHAT ARE YOUR PRIVACY RIGHTS?

In the UK and EU, you have certain rights under applicable data protection laws. These may include the right (i) to request access and obtain a copy of your personal information, (ii) to request rectification or erasure; (iii) to restrict the processing of your personal information; and (iv) if applicable, to data portability. If you are a resident in the UK and EU and you believe we are unlawfully processing your personal information, you also have the right to complain to your local data protection supervisory authority.
